

I. Pre-order regulations for coins sold with pre-ordering (17 Jan 2022)

- Pre-ordering is possible for the commemorative coins offered in the issuing programme each year.
- Submission of a pre-order request is not considered to be an order, and the acceptance and registration of such a request does not constitute a completed order confirmation.
- Information on the date when pre-ordering becomes possible is provided in the Mint's electronic newsletter and the press release published on the MNB's website.
- Pre-order requests can be submitted within one month (30 calendar days) of the above date. Registration is closed at the end of the pre-order period, and subsequent requests are not accepted.
- Pre-order requests may only be submitted electronically on our website (www.penzvero.hu), using the pre-order page linked to the pre-order announcement.
- Pre-order requests received electronically are automatically registered by the system in the order of receipt.
- Customers submitting pre-orders automatically receive an e-mail confirming receipt of the request.

Natural persons (registered users) may pre-order a maximum of 3 pcs of each product. **One online pre-order request may be submitted per registered user.** Customers who pre-order with receipt in person may authorise a third person to receive the pre-ordered items, but in all such cases a written authorisation, in the form of a private document providing full evidence signed by two witnesses, is required. The authorisation must contain the information necessary for identifying the pre-ordering party and the pre-ordered items (e.g. name, address, name of product). In certain cases, the Hungarian Mint Ltd. (Company) reserves the right to stipulate receipt conditions differing from the above. **A natural person may undertake receipt in person for a maximum of 3 people based on such authorisation.**

- Group pre-ordering is not possible; natural persons may only submit pre-order requests on their own behalf.
- We reserve the right to alter the prices and issue dates announced in the pre-order publication and to limit the quantities available for pre-ordering. The prices stated in the publication do not include delivery costs. In the case of oversubscription, the limitation of quantities occurs based on order of receipt and the rules of allocation.
- The issuer MNB reserves the right to modify the maximum announced quantity that can be minted and the other conditions of the issuing programme.
- Prior to issue of the items in question, pre-order requests can be withdrawn in writing.

- We ensure the opportunity to take personal receipt of the pre-ordered items for a period of one month from the date of issue as published for the specific item in the Hungarian Official Journal.
- Pre-ordering parties will receive an automatic e-mail notification (pre-order notification) prior to the specific issues. Information on specific issues can be found in the Hungarian Official Journal, our electronic newsletter and, from the date of issue, on our website.
- A maximum of 60% of the total quantity announced for minting is available for pre-order. The remaining 40% is intended for export and retail purposes, including the Hungarian Numismatic Collectors Society (MÉE). Items that are not allocated in the course of pre-ordering are available for sale from the date of issue, while items that were pre-ordered but not picked up become available for sale after expiration of the one-month receipt period. In justified cases, deviation from the distribution ratio is possible, with approval by the chief executive officer.
- Following expiration of the pre-order period, additional pre-order requests or reservations may not be submitted.
